I/WE UNDERSTAND AND AGREE TO THE FOLLOWING SCHOOL COMMITMENTS:

APPLICATION PROCESS: I/We understand that a non-refundable application fee of \$50 per family is due now and a security deposit equal to one month’s tuition is due by May 1st (or upon enrollment). I/We understand that half of our deposit will be refunded if we withdraw with notice before July 1st. There are no refunds after July 1st and before classes begin. Once classes begin, the security deposit will be applied as the last month’s tuition, and will be refundable on a prorated basis if I/we withdraw from the school in good standing.

SCHOOL FEES: I/We understand that our tuition will be due monthly on the 1st of the month, and considered late after the 10th.

REGISTRATION FORMS: All must be completed and submitted by the due date before the child may attend class.

CLASSROOM: I/We agree to work as a teacher’s assistant in the classroom one session per week.

PARENTS’ CLASSES: I/We agree to attend one evening Parents’ Class each month August through May.

MAINTENANCE: I/We agree to participate in 8 hours of school maintenance per year.

SCHOOL JOB: I/We agree to hold at least one school job, or to pay an additional \$75 each month to buy out of a job. (For Little Ones families, holding a job is optional.)

SUBSTITUTE AVAILABILITY: I/We agree to be available as an on-call emergency substitute as needed.

COMMUNITY EVENTS: I/We agree to complete 4 community event hours during the school year.

FUNDRAISING: I/We understand that fundraising is an important part of our contribution to the school, and I/we will support school fundraising efforts and will consider a voluntary contribution to the annual fund (\$250 suggested).
